Resisting Arrest

Your complainant, PO A BAUDAUF, being duly sworn, deposes and states that I work at the premises known as 630 N CLINTON AV in the City of Rochester, State of New York. That on the 1 day of AUGUST, 2013, at approximately 10:27 AM PM at the premises known as 1509 E MAID ST in the City of Rochester, State of New York, I accuse said defendant(s) D'WAYNE IVORY

of intentionally, knowingly and unlawfully committing the class A Misdemeanor of RESISTING ARREST in violation of Section 205.30 of the Penal Law of the State of New York.
The factual basis for the above being UPON PERSONAL KNOWLEDGE or UPON INFORMATION AND BELIEF as follows:

COMPLAINANT STATES THAT ON OR ABOUT THE ABOVE LISTED DATE, TIME AND PLACE THE DEFENDANT(S) DID: Pull away from officers as they tried to take him into custody. He then ran a short distance before turning to engage officers and tackling me. He then continued to struggle to get up pulling away his arms and kicking his feet while we handcuffed him on the ground.

That by the above actions, the defendant(s) intentionally prevented or attempted to prevent a police officer or peace officer from effecting an authorized arrest of himself or another.
To wit, the defendant was under arrest for Harassment 2nd the factual basis for the authorized arrest are as follows: The defendant did shove me in an attempt to get by me to get at his girlfriend.

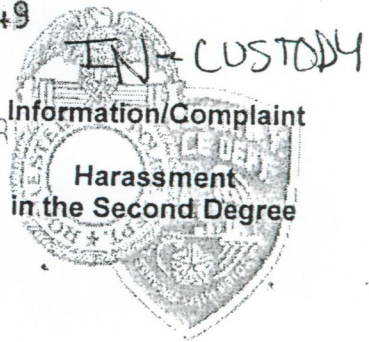
